"National Drug Observatories Facing New Global Challenges: Towards a Joint EU–CELAC Evidence-Based Response"

Context and Relevance

The global dynamics of drug markets—ever more diversified, interconnected, and featuring the presence of new psychoactive substances—pose unprecedented challenges for public health, security, and social cohesion. We are witnessing increased availability and use of synthetic drugs and new psychoactive substances, alongside traditional drugs, together with the expansion of illicit markets in digital environments and the use of the internet for distribution. Added to this are environmental impacts, violence associated with drug trafficking, and related offenses such as money laundering and trafficking in firearms. New patterns of use are also emerging, linked to mental-health issues, social vulnerabilities, and structural inequalities, which calls for comprehensive, evidence-based responses across health, security, and social-policy domains.

Drug policies therefore face the challenge of responding with agility and effectiveness in a changing context while ensuring a balanced approach. In this scenario, National Drug Observatories (NDOs) are essential to provide scientific, comparable, and up-to-date information that underpins strategic decision-making, makes it possible to anticipate trends, and prepares us to respond to new threats.

In much of Latin America and the Caribbean, NDOs and their information and early-warning systems have made significant progress in recent years thanks to strengthened technical capacities, the adoption of common methodologies, and growing international cooperation. Nonetheless, important challenges persist, such as fragmentation and heterogeneity in data sources; insufficient integration of data from different sectors (health, security, justice, social policy); lack of specialized technical and human resources; and constraints on producing forward-looking analysis and systematic policy evaluations.

Objectives of the Meeting

The European Union programme COPOLAD III, led by FIAP in consortium with IILA and in partnership with EUDA and GIZ, advances drug policies that are more humane, effective, and evidence-based. Within this framework, one of its priority lines of work is to strengthen National Drug Observatories (NDOs), promoting their technical and institutional development to improve the generation, analysis, and use of information as a basis for decision-making.

Within this framework, and as the culmination of almost five years of joint work, the meeting "National Drug Observatories Facing New Global Challenges: Towards a Joint EU–CELAC Evidence-Based Response," organized by FIAP in collaboration with Mexico's National Commission for Mental Health and Addictions (CONASAMA), will be held. The event will bring







together NDOs from 20 countries in Latin America and the Caribbean, together with Spain, France, Portugal, Poland, and Ireland, as well as strategic organizations such as EUDA, the CICAD-OAS, and UNODC.

This meeting is an opportunity to share achievements, lessons learned, and experiences, as well as to jointly define future cooperation priorities. It seeks to consolidate a shared vision of the role of NDOs as pillars of evidence-based drug policies; to strengthen technical and operational cooperation between countries and regions; and to lay the foundations for a possible COPOLAD top-up aimed at addressing emerging challenges through coordinated, inclusive, and sustainable solutions.

The purpose is aligned with the La Paz Declaration (2024) of the EU–CELAC Mechanism, which underscores the need to reinforce NDOs and generate robust scientific evidence as the foundation for comprehensive, balanced, and human-rights-based policies.
